<b>How to get there</b>		<b>Radisson Blu Hotel, Zurich Airport</b>
	<b>from Airport</b>	The hotel is located between the Arrival / Check-in 1 building and the main airport building Airport center / Check-in 3. The subterranean walkway to access the hotel is found between level 0 of the airport center and check-in 1.
	<b>by train</b>	Connections from Zurich Main Station to the airport’s train station, Zurich Flughafen, leave about every 5 minutes. To get to the hotel from the train station, you go up to the 1st level of Zurich Airport and walk about 3 minutes in the direction of check-in 1. The hotel is situated on your right hand side.
	<b>by car</b>	The hotel is easily accessible from the motorway A1. Follow the signs to the airport. The hotel parking is located in Parking P1, on the 8th floor
